## **Are you embarking on a data governance initiative and wondering where to start?**

You're frantically searching the internet, trying to define terms and figure out what needs to be done when. You're wondering where you are going to find the time to do all the research to be able to get this initiative off the ground.

You wish you had a clear pathway set out in front of you and someone who could tell you what applies to your organisation.

## **Why work with me?**

I want to save people from making mistakes and making data governance harder than it has to be, because it is a challenging thing to do.

I want to help you by giving you the dos and the don'ts. That's what the Data Governance Launch Pad is all about.

# 1:1 support for the first 6 months of your Data Governance Initiative

Whether it's your first day working in data governance for your organisation, or your initiative has been going for a few months, we will work through what needs to be done together. There is no one size fits all when it comes to data governance. We'll tailor the work to your organisation.

## In the first month, you will get:

Five licences for my online Data Governance course. This enables your Data Governance Team and colleagues, including Data Architects and Change Management Team, to get up to speed with key concepts and provides a clear pathway to follow.

An Action Planning Workshop Day where we start by reviewing what you already have in place and what you want to focus on. We'll identify the gaps and agree on actions to address them. You can ask any questions that came up when you went through the online course.

A one hour coaching call where we can talk through how you're getting on since the workshop. I will give you external validation of your approach and if you are stuck, I will guide you.

## In months 2 to 6, you get:

One Workshop Day per month. We'll look at the plan we have agreed to decide what we are focusing on. I am here to hold your hand over the 6 months as you develop your Data Governance Framework.

A one hour coaching call per month. How you use this time is up to you.

Work on documents together

During the 6 month period you will also be invited to join two of my quarterly Data Governance Mastermind sessions. This gives you additional support and the opportunity to meet and learn from your peers in similar roles.

## You can also choose to access these Optional Extras:

Expert Guest Coaching Sessions covering topics like Data Catalogues, Data Quality, and Data Storytelling to help you deepen your knowledge of these areas.

Helping Hands where one of my associates will help you do some of the work so you can make even faster progress.

Email support for quick queries so you can get answers without waiting for your next coaching call or Workshop Day.

Data Governance Maturity Review with or without detailed analysis/commentary so you know where you are with your data governance, where you need to get to, and what your next steps are. This can be used to benchmark your progress. You probably have some pockets of people trying to do the right things across the organisation already so you can identify these and build on them.

Additional coaching calls so you have more 1:1 support to go over issues more deeply.

## Q&A

**Who is this for?** Corporate or large public sector organisations who are just starting a data governance Initiative.

---

**How much data governance knowledge do we need to get value from this?**

None. I will give you access to my online training course which will get you up to speed before our Action Planning Workshop Day. I will answer any questions you have and provide practical support.

---

**We started implementing data governance a few months ago and it's not going too well. Would this help us?** Yes it could. Let's have a chat about what's been happening to see if this is the best solution for you so we can get you on the right track.

---

**Do we have to decide on optional extras at the start?** No, you can add them in as needed. We'll talk through your requirements during your Discovery Call. Then as your initiative progresses, you can decide if you need any additional support.

---

**What will we cover during the monthly workshops?**

We will look at the tasks which need to be completed to make your plans happen. Sometimes it will be a workshop where we spend the day together and work through a topic, discussing and agreeing things. Another day could be spent with me reviewing documents you have drafted. I have used them to run conceptual data modelling workshops for clients; or to run engagement meetings with senior stakeholders; or to facilitate and support the first Data Governance Committee meeting. We'll do whatever is most useful to you.

---

**If we need more hands-on help than the workshops and coaching calls, can you provide that?** Yes, you can make use of my Helping Hands by asking one of my associates to do some of the work for you. They can run conceptual data modelling workshops to help identify and brief Data Owners and Data Stewards. They can also help Data Stewards with completing data definitions and data quality rules. Talk to me about your requirements.

---

**What happens at the quarterly Mastermind?**

It's a one day event for people to come together to get answers and support in addressing their data governance challenges. You get to meet with your peers who are doing similar roles, and develop a wider network. The main focus is the hot seat, which means everyone gets specific time during the day when the whole group considers their data governance challenges. Everyone, including me, gets to share their experience and advice to come up with practical actions you can take away.

**What happens at the end of the 6 months?**

Your in-house team will have all the skills and knowledge they need to be able to continue with the data governance initiative we have planned out. The purpose of the Data Governance Launch Pad is to give you the capability you need to succeed.

# How RenRe used the Data Governance Launch Pad to implement Data Governance for their Data Mesh

Wouldn't it be great if the first thing you did when you embarked on a data governance initiative was sit down with an expert and work through your first steps?

That's exactly what happened when Renaissance Reinsurance's (RenRe) VP Corporate Risk, Úna Scallan, started her role as Data Governance Lead. Her company had invested in the Data Governance Launch Pad.

Úna said: "On my first day, we had a workshop with Nicola. She had given us access to her course so I had gone through that 24 hours beforehand. The content of that was simple in the best way. It was easy to grasp, it wasn't full of jargon. And it created a framework for us, so I was able to see we had a plan.

"We came away from that day with a much better understanding of what we were going to do."

Úna and her colleagues were inspired by my focus on proactively managing data to achieve their business strategy. They put together a detailed framework document setting out how their data governance initiative would benefit RenRe. Then they embarked on Data Discovery Workshops, which Úna described as 'crucial'.

She said: "Nicola facilitated the first one. Then we were able to rinse and repeat. We could identify within each department what potential data products we had. Then we could prioritise them. That set up a really good framework for the rest of the year."

RenRe were implementing Data Mesh so they were pioneering a lot of the work they needed to develop their federated governance framework.

Úna said: "It was often tough going at the start when there's a lot of uncertainty, and you're trying to figure out the best approach for your organisation. Nicola was a huge support and a sounding board for what we were thinking and then would steer us in one direction or another, which was really helpful.

"We did three day-long workshops and then decided we wanted to use the rest of the time for coaching calls, as needed. When you are iterating it's useful to have an hour here and there to touch base and run something past Nicola. It was really helpful to be able to have those conversations with someone who knows what they're talking about and could educate us."

RenRe was able to get its Data Governance Framework adopted widely across the organisation within 9 months of starting the Data Governance Launch Pad.
