

#### Who is this for?

Chief Data Officers, Heads of Data, Data Governance Managers or Data Leads at large organisations who want, or need, to implement data governance. You might have started and are finding it difficult, or you're finding it difficult to get started

### How does Data Governance Coaching work?

I work with you as you design and implement your Data Governance Framework.

Most coaching sessions will take place on a video call. You tell me your latest challenges, or ask me questions, and I will give you recommendations. However, you might want me to attend meetings with you virtually. I can talk to your senior stakeholders. You can also ask me to use a 'call' to review documents so you don't need to attend at all.

I enable you to speed up the process, avoid the pitfalls, and develop a framework which works for your organisation. There is no one size fits all.

### Why six months?

Data governance takes a long time to do. It's not a project, it's a process, and as you can see from the Six Principles of Data Governance, it will evolve over time as you reap the benefits.

Data Governance Coaching provides you with practical support and guidance as you work through this. You know you have a call lined up to talk about what's happening if you get stuck.

#### How often will we meet?

Since then, I've worked a lot in the financial sector, publishing, higher education, and the public sector. I've made it my mission to help as many people as possible be successful with data governance.


Your data is valuable. It enables you to make key decisions with confidence. Having the right data, and ensuring it is good quality, is essential.
